### SIA SPILIOPOULOU ÅKERMARK

Jur. Dr., Associate Professor in International Law (Uppsala University) and Director at the Åland Islands Peace Institute (Mariehamn, Finland). Sia has worked in academia as well as with non-governmental organizations and research institutions in Europe, East Africa and the USA. Her work focuses on diversity, pluralism, minorities, territorial autonomy solutions as well as on legal restraints in securitization and the use of force. In 2018 she completed a large multidisciplinary project entitled “Demilitarization in an increasingly militarized world: International perspectives in a multilevel framework”. She served for many years as expert member and president of the Advisory Committee on the Framework Convention on National Minorities of the Council of Europe. Among her works are: *Justifications of Minority Protection in International Law* (Kluwer 1997), *Towards Openly Multilingual Policies and Practices Assessing Minority Language Maintenance Across Europe* co-authored with J. Laakso, A. Sarhimaa and R. Toivanen (Multilingual Matters, 2016), *Demilitarization and International law in Context – The Åland Islands*, co-authored with S. Heinikoski and P. Kleemola-Juntunen (Routledge, 2018) and “The Faroe Islands, Greenland and the Åland Islands in Nordic Cooperation”, with K. Creutz (FIIA, 2021).



### ELISABETH ALBER

Senior Researcher and Head of the “Federal Scholar in Residence Program” at the Institute for Comparative Federalism of Eurac Research. Elisabeth’s work examines law and politics in federal and regional States, minority rights and territorial autonomies, institutional innovations, and participatory democracy. She also has a keen interest in decentralization processes, cross-border cooperation, and civic education. Her recent publications include “South Tyrol’s Model of Conflict Resolution: Territorial Autonomy and Power-Sharing” (in *Power-Sharing in Europe*, edited by S. Keil and A. McCulloch, Palgrave 2021), *Von Government zu Governance. Direkte und Deliberative Demokratie in europäischen Mehrebenensystemen* (co-editor with C. Zwilling, Nomos 2021), “Academic Freedom and Cross-Border Cooperation: Conceptual Reflections and a Contextual Analysis in Relation to the South Tyrol Alpine Borderland” (in *Academic Freedom under Pressure*, edited by L. Violini et al., Springer 2021). She is vice-president of the South Tyrolean Political Science Association (where she co-edits the South Tyrolean Political Science Yearbook) and co-convenor of the IACL-Research Group Constitutionalism and Societal Pluralism.
